Notice of 2022 Rebate Changes for Trade Allies

The following changes will take place on January 1, 2022. The application or invoice date determines which rebates and requirements are applied to the project. Customers have 90 days from the invoice date to submit rebate applications to City Light. Rebates will not be paid on projects that are not yet installed. Please ensure you are familiar with the below changes:

LIGHTING TO GO INSTANT DISCOUNTS

Lighting to Go instant discounts are changing significantly in 2022. Due to HB 1444, general service lamp measures are no longer cost effective. Lamps that are no longer eligible in 2022 include:

- LED - Integral - Omnidirectional
- LED - Integral - R/BR/PAR 20, 30, 38, 40
- LED - Integral - Decorative
- LED - MR16 or PAR16

In addition, City Light is aligning Lighting to Go instant discounts with a regional effort with PSE and SnoPUD. New 2022 measures include:

- HID LED lamps
- LED downlight fixtures > 1800 lumens
- Interior/exterior LED fixtures

Lighting to Go instant rebates are available from [participating distributors](#)¹. Contractors and customers pursuing Lighting to Go discounts cannot also apply for direct incentives from City Light.

SPACE HEAT

HVAC midstream rebates (available from [participating distributors](#) ²) will remove Tier 1 residential new construction traditional heat pumps from eligibility. Code changes render this measure not cost-effective.

WATER HEAT

Hybrid heat pump water heater midstream rebates will see the following changes:

- The minimum size of qualifying equipment will be reduced from ≤ 200 gallons to ≤ 120 gallons to align with the Advanced Water Heating Specification from Northwest Energy Efficiency Alliance (NEEA).
- Rebates will use NEEA tiers instead of UEF performance criteria to align with Washington State Energy Code.
- Midstream retrofit HPWH's meeting NEEA Tier 1 will be reduced from \$500 to \$300.
- Midstream retrofit HPWH's meeting NEEA Tier 3 and 4 will remain at \$500.
- Midstream new construction HPWH's meeting NEEA Tier 3 will no longer be eligible for a rebate. Code changes render this measure not cost effective.
- Midstream new construction HPWH's meeting NEEA Tier 4 will be decreased from \$500 to \$150.

ULTRA-LOW TEMPERATURE FREEZERS (LAB GRADE)

ENERGY STAR rated Ultra-Low Temperature (ULT) Freezers purchased in 2022 are now eligible to receive discounts from participating distributors. ULT freezers purchased in 2021 can still receive direct rebates from City Light through March 31, 2022.

COMMERCIAL KITCHEN EQUIPMENT

Due to the 2018 Commercial Energy Code and requirements of HB 1444, commercial cooking rebates are no longer available for:

- Commercial fryers
- Commercial hot food holding cabinets
- Commercial steam cookers
- New Construction Demand Control Ventilation for Kitchen Exhaust. Retrofit applications are still eligible.
